



- Preferred Material: Digital files on CD or zip disk accompanied by laser printout. Resolution on all images should be 300 DPI. High resolution PDF files CMYK (for print), High resolution JPEG, CMYK TIFF files, and EPS files are accepted. InDesign files are accepted. Use of any other program will result in additional charges of \$40 per hour. Ads may be e-mailed but we prefer a file that has been compressed with either Zip-it™ or Stuff-it™.
- For color ads, a color guide must accompany digital files.
- Bleed: Full page. No additional charge. Pages should be prepared bleed size (not trim). Images and text should be held within a 1/8" space from trim and 1/4" space from bleed to ensure they do not trim.
- Ad materials are due ten days after closing date. (*Exceptions must be cleared with the editor prior to deadline.*)
- Contracts may be canceled at short rate any time before closing date for space reservations. **After closing date, the advertisement cannot be canceled.**
- Latest previous advertisement will be repeated when materials are not received within ten days after closing date or if no written instructions to do otherwise are delivered to GPQ headquarters.
- Color ads are sold based on space availability.

GPQ and PGQ Advertising Terms and Information

- Preferred positions: Editor will attempt to follow advertiser's position request.
- Services available at no additional charge: Advertisement supplied as high res (300 dpi) CMYK, PDF, or TIFF file.
- Services requiring additional charges: Photo composition, typesetting and pasteup, scanning color separations, camera work, enlargements or reductions of supplied material, reprints, and overruns. Charges quoted on request.
- Inserts: Please consult with editor for mechanical and copy specifications and additional charges.
